

**CERTIFICATE OF REGISTRATION (COR) FEE SCHEDULE (EFFECTIVE JULY 1, 2007)**

CORs are issued on a calendar year basis unless stated otherwise on the COR. All COR applications (except rehabilitation) must be accompanied by a \$10 nonrefundable handling fee, which is in addition to the below-listed fees.

Applications for activities which require an inspection (e.g., private pond, aviculture installation, bobcat propagation) must also be accompanied by a \$100 nonrefundable inspection fee. If an application is approved, the COR will be issued and applicant billed for the balance due, which must be submitted within 15 days of receipt. Every effort will be made to combine like activities on one COR. NOTE: THERE ARE NO DOLLAR AMOUNT THRESHOLDS--IT'S EITHER PERSONAL USE OR COMMERCIAL USE. ALSO, THERE IS NO DIFFERENTIATION BETWEEN RESIDENT AND NONRESIDENT FEES.

**R657-3 COLLECTION, IMPORTATION, TRANSPORTATION, AND POSSESSION OF ZOOLOGICAL ANIMALS**  
Except rehabilitation (no fees)

**R657-4 POSSESSION OF LIVE GAME BIRDS (PRIVATE WILDLIFE FARM/AVICULTURE INSTALLATION) (5 year COR)**

**R657-11 FUR DEALER OR FUR DEALER'S AGENT** (engaging in the business of buying, selling, or trading green pelts or parts of furbearers within Utah)

**R657-13 FISHING CONTESTS** (a separate application must be submitted for each contest. The initial application submitted must be accompanied by a \$10 nonrefundable handling fee and \$150 initial COR fee. This fee will cover all fishing contests during a single year for a particular club/federation. Changes in dates, location, or species for a particular contest, however, will be treated as a \$10 amendment)

**R657-16 AQUACULTURE AND FISH STOCKING**

**Display** (holding live fish in aquarium for viewing/displaying [personal]; restaurant menu item) [commercial])

**Institutional aquaculture** (NO FEE if institution is identified in memorandum of understanding with Board of Education)

**Private fish pond** (pond, reservoir or other body of water which is contained on privately owned land and used for holding or rearing fish for a private, noncommercial purpose; cannot be developed on natural lakes or natural flowing streams)

**Private stocking of public water** (private stocking of a water that is on privately owned land and that is not stocked or otherwise actively managed by the Division; multiple stocking within the same year may be authorized but must be requested on initial application)

**Short-term fishing event** (an event where privately acquired fish are held or confined for a period not to exceed 7 days for the purpose of providing fishing or recreational opportunity and where no fee is charged as a requirement to fish)

**R657-46 DOG TRIALS**

\$30 renewal fee for those clubs that presently have or have had a COR for dog trials/meets (\$75 initial fee for new applicants).

<sup>1</sup> If the application is not received on or before the designated ending date, a \$10 late fee will be assessed; if the application is not received within 30 days of the designated ending date, the application will be treated as an initial application and initial fees will apply.
