**Discussion Highlights**

Range wide Sage grouse Listing: 90 day finding concluded March 26. Results of findings should be announced in about 1 week.

Discussion on conservation plan:

Q: Can our plan be flexible or will we be locked into a plan dictated to us by the USFWS?

A: Our plan can be flexible; hence the reason for this group, to create a local plan specific to our area. However, our plan must meet the PECE Standards and we should be consistent with the

state and county plans.

Some of the issues that we want to elaborate on in our plan are:

The group volunteered to help UDWR with lek counting this year. Todd gave a brief tutorial on what data needed to be collected and how often. Interested parties will contact Brian Maxfield, UDWR.

The group will also volunteer for brood surveys in August/September of this year; coordinate with Brian.

John Busch stated he will have the Questar field operators report any sage grouse sightings. They will be told what to look for and what information to record should they see a Sage grouse.

Monitoring is the key issue and topic of our conversation. Monitoring is critical from this point forward and is needed in all phases of the plan. Documenting the effects of artificial perches, level of activity, predation, habitat, etc. is a must in order for us to track our progress. This will also insure data accuracy and eliminate gaps in data.

It was suggested that the UDWR keep all of the data for the monitoring that will be done with this plan.

The 40 year history of Sage grouse and habitat needs to be pulled together, gaps filled in, and summarized for our plan.

It was suggested that the group put together a brochure that could be distributed to the public to solicit their help in data collection. We do not want the public going out on organized searches but they should know who to call and report information to in case of incidental sightings. Perhaps a sage grouse conference for the community? Need to be very careful to be respectful of private land owners. It is not our intention to promote trespassing.

It was suggested our working group meeting be extended to 3 hours to better accommodate individuals coming from Salt Lake City and Denver. We would like to get more accomplished while they are here. We should also try to schedule our meetings close to other meetings that bring in participants from Salt Lake and Denver (ie: Mitigation Bank meetings, Oil & Gas Collaborative Working Groups, etc.)
