The passage of the Albrecht bill allows for the director to increase permits WHEN cougars or bears ARE proven to be a detriment to herds, but the current date from BYU is not supporting the increases on the amount of units we are seeing increases imposed. The Bookcliffs spike elk hunt needs to end. As a hunter of the Bookcliffs and an outfitter who lives in Green River Utah I have years of experience and observations there., I spend all year and especially each fall on the unit and have done so for the past 30 years, I strongly disagree with the spike hunt. The reduction of mature bulls is alarming. The elk herd is not at objective and allowing some more mature bulls to be on the units does not compromise the forage available. We are harvesting more spike elk than can be sustained to keep a healthy mature bull herd. The reduction each year of mature bull hunting to allow for spike elk hunting is not an opportunity improvement for a hunter who chooses to hunt a mature bull on a unit such as the roadless Bookcliffs who many dream of the backcountry hunt. Spike elk hunts should be on units at herd objective and not on units that are under overall population objectives. The Bookcliffs is the area Utah is struggling to manage a healthy elk herd and continuing the spike hunt is compromising the unit. The argument that the spike hunt is an opportunity for families to get together to hunt is not what I see on the spike elk hunt. It is much more made up of adults males and not wives and kids, especially the roadless portion.

I will probably continue to comment on this proposal as new information comes forward during the remaining 3 RAC meetings, but I want to address a couple things Covy brought up in the reasoning behind taking away bonus points and imposing the waiting period for this hunt.

Before I do so, here is what I commented before the Northern region RAC meeting: (this is just for context)

While I support this proposal, I do have a couple concerns.

First of all, thank you for what you all do, and thank you for providing us with the best possible public process during this pandemic.

This is a great opportunity for hunters to be able to pursue an animal that many may never draw in their lifetime.

That said, I don't think this is a proper tool to try and reduce point creep.

To make this effective, you need as many hunters on the ground as possible, and such a deterrent--especially the lifetime waiting period--will most certainly stop the vast majority of would-be bison hunters from attempting this hunt.

It's already a VERY difficult hunt, and most likely limited only to hunters with access to pack animals, and hunters who are in extremely good shape.

A couple other key points to consider.

- 1) Our bonus point system is used in Limited Entry hunts... This is not a limited entry hunt, there is no limit on who, or how many can purchase the tag.
- 2) The lifetime waiting period is only for once in a lifetime hunts... This is very likely a hunt that will continue for several seasons, and as such, this is not a once in a lifetime hunt, and that waiting period should not apply.

All that said, if the waiting period and bonus points were only forfeited if the hunter is successful, then perhaps I could consider that a fair compromise.

PS: since this is the only comment I have regarding the proposals, can I suggest you read the comments people have given? (provided they're suitable for air time)

With the extreme circumstances causing the meeting to be closed from public--in person--comment, I would like to hear the comments of other sportsmen, as well as those of the sportsman's groups that will be

submitted while I'm watching the meeting from home.

My concerns were brought up very well by Justin during the RAC meeting, and my thanks go out to him on that... it was an excellent discussion, and my views couldn't have been better represented.

Since this "version" of the process gives me a chance for some rebuttal, I'm going to take it;)

Covy suggested that this tag is no different than someone buying a CWMU tag, or purchasing an expo tag since they're sold "over the counter".

In a way, he's correct... if I've already drawn a moose tag, I can still buy a CWMU tag, or even purchase another moose tag through the expo, or a voucher that's offered at a similar banquet.

And of course, if I bought one of those tags before drawing them, I would not be eligible to put in for that hunt through the public draw because I would have incurred the waiting period... That's where the similarities end though.

The success rate on OIL CWMU and/or "expo" tags are almost 100%... these are VERY high quality hunts (and that's why they sell for many tens of thousands of dollars each)

To call them "OTC" is not a fair statement... unless you're VERY wealthy, you can't just go buy one of those tags.

This proposed hunt really is "OTC", and truly open to the public, and seemingly affordable enough that anyone could reasonably buy this tag.

Success rate wise, this is a VERY LOW success hunt... in fact, with the pressure required to do what the division is hoping, you can expect the actual success to be less than half of what it's already been for the hunters that have hunted it in the past.

I guess you can try offering it as proposed, maybe you'll get some "takers", however if the division really wants to pressure the animals, it needs to be structured in a way that encourages hunters to come out en-masse and really push the animals off the unit.

Bison are very pressure sensitive, maybe even more than elk, and if we want them to change zip codes, the orange army needs to be an army, not a spattering of people willing to "take their chances" on a once in a lifetime hunt.

Personally, I have zero bison points, but if I ever draw my moose tag, it's next on my list of OIL hunts... there's NO WAY I'd throw away my chance to hunt on the Henry mountains for a bison (the only genetically pure free range bison herd in the nation), just to say I got to hunt "bison".

I would like to address the permit numbers for desert bighorn sheep on the Kaiparowits units. As someone who has over 20 years experience with sheep on these units from my time as a being a M.S. graduate student studying them, a Utah division of wildlife biologist over these units, and now currently a sportsman and sheep hunting outfitter, I am concerned about the rapid increase in permits the last couple of years particularly on the west subunit. I am well aware of the balance to harvest rams when you have them, before issues such as disease have a potential impact on them. However, if you look at the Zion unit which for years has been the best trophy unit in the state, this is no longer the case. Using the Zion desert sheep unit as an example where consistently high permit numbers along with aggressive removal of sheep for transplants, this unit is now a shadow of what it once was in terms of numbers and quality of rams. Tag numbers are being cut again on Zion for 2020, to a point nearly half of where they were at their peak. While the Zion has challenges with nearby communities creating exposure to domestic sheep or goats, the Kaiparowits does not. The Kaiparowits West subunit has been a great unit for hunters looking for big rams for many years. But with the current trend in increasing permit numbers, this will not last. In addition to draw permits, the Kaiparowits units have 2 conservation permits each year, at least one of those possibly both will harvest on the west. Additionally, there is one K-west specific tag given to the SLC Hunt Expo convention. And in 2019, the statewide conservation and statewide sportsman permit holder's for desert sheep BOTH killed on the K-west. So there were four extra rams killed on the K-west in 2019 above and beyond the draw tags. With the current declined status of the Zion unit, the K-west will continue to bear the brunt from extra harvest. Please keep all of this in mind when considering recommending adding any new public draw permits for 2020. With elk we have a handful of units and with deer we designate a couple units as premium units with higher age objectives and we manage for overall the best quality. My question is why can we not do that for desert or Rocky Mountain sheep as well? The units across extreme southern Utah such as the Zion and Kaiparowits most notably, which have Nevada and Arizona transplanted sheep and genetics, have proven they can produce great rams if given the opportunity. I ask the Wildlife Board and RAC's to not increase the K-West tags for 2020. The unit can not keep producing enough older, trophy rams with the continued permit increases.

The K-west and east subunits have not been helicopter surveyed since 2018, and the Escalante has not been surveyed since 2017, yet permit increases have been recommended in these units again for 2020. The bighorn sheep management plan has a guideline to recommend permit numbers based on 30 to 60% of the total rams counted that are six years and older. I am requesting that on units like the West that have the ability to produce bigger rams with better trophy potential, that the 30% guideline and nothing higher is used for setting permits. Based on the last survey on the K-west subunit In 2018, there were 40 rams counted ages 6 and older. Using a 30% guideline for a permit recommendation, that would put the number of harvested rams on the West at 12 for 2019. In 2019 there were 14 rams killed on the unit with again an increase proposed in 2020, plus the

extra tags as mentioned. I don't believe that the majority of those that have waited to draw permits for these once in a lifetime species, are interested in shooting just any ram. There are other units across Utah that are not capable of producing as big a rams at the Zion and Kaiparowits units. We should use those units as the types of units that increased opportunity can occur. I urge the Wildlife Board and RAC's to manage the units like Zion, and Kaiparowits West and East units that have best demonstrated the ability to produce the best rams in Utah, to be managed a bit more conservatively from a tag number standpoint, using the low end 30% guideline as previously mentioned. There are so many rules and specifications on the rule that it is hard to trap legally even if we want to. If a trap tag is lost because of an animal struggling and the game warden sees it we will be in trouble. If the gap in a trap is slightly less than 3/16th of an inch we get in trouble even though we made the effort to make it as close as possible. There is a serious lack of trust between game wardens and trappers and hunters alike. If we notice illegal activity going on and report it we are the first ones they condemn. If we are trying to be honest and call in about a question, concern or something that happened, we are the ones reprimanded. On private property I would like to see trapping restrictions lessen as far as the trap number doesn't need to be on a trap on private property. I would also like to see that a game warden get a warrant to come onto private property instead of trespassing. If someone has gone through the process to buy tags and licenses why are they the first ones that game warden will try to prove guilty when we are paying their salary. And who keeps tabs on them to make sure they are following the rules to the strictness that they wish we adhere to. I would hope that cougars and possibly bears could be trapped during the appropriate season if we have a tag. Especially in areas where houndsman struggle hunting them. I would also like to see some predator management in national parks somehow. We also need to start managing raccoons, skunks, ravens and hawks to some extent somehow. Beaver Concern:

On October 11, 2019 a press release was issued by DWR stating that there was currently 370,000 deer in the state. This press release would have been after the 2019 spring counts and after the 2019 Archery and muzzle hunts. Covey Jones quoted on this press release that "We have more bucks on the statewide landscape currently than we have ever had". Two months later on December 10th at the Southern RAC, the same Colby Jones told us that he knew the Beaver and southern units had taken a big hit in the deer herd. How can we believe the numbers that the DWR claims to have on the Beaver unit. They are right, the Beaver unit has taken a big hit in the deer herd. But this is just not over one year, but has been going down for several years. If all of these deer died in one year, you would be stumbling over dead Caucasus everywhere. Funny how the DWR models and formulas were fine until concerned hunters began to really voice an opposition. the past couple years.

As for the Beaver unit cuts. They are cutting 900 tags from 3,000 to 2,100. Glad to see some type of recognition, but this will not be enough to ever bring this unit back. I would like to make some suggestions from being a life long hunter of the Beaver unit and a very concerned hunter.

- 1. The unit has many open sage brush areas that are easy buck kill for hunters, especially during the rifle hunt. 2,100 hunters, hunting very few bucks will not help the deer herd. This unit needs to have another 900 tags cut, just like the Cache unit to have any chance of helping the buck herd.
- 2. The unit is to large to manage, and many tag holders hunt the same small areas. These areas of open sage brush ridges naturally make it a hot spot for hunters. The area needs to be split, so that it can be managed for the small amounts of deer that are in these areas. An easy split would be the East and West side of 1-15 and maybe even a North end could make a 3rd split.
- 3. The statistics show that in 2018 there were 13,500 deer on the Beaver. In 2019 the number went down to 12,000 so 350 tag cuts were made. Obviously the 350 tag cuts were not enough, because now cuts of 900 tags are being made. I think it is time to get ahead of the problem and not keep chasing the problem. Shutting the unit down is your best option to get ahead of the unit, but if not then tag cuts better at least double the proposed amount or it is just a hope that 900 will be enough of a cut.
- 4. It was mentioned that the Beaver was the 2nd worst in the state for deer health and conditions. The Cache was probably number one, so they at least tried to get ahead of the problem with more tag cuts. Why in the world if deer numbers are drastically on the decline would you still have any doe permits. The Beaver did drop from 50 tags to 25 tags, but if you are dropping deer that fast, why would you want to have any tags on the doe herd. An interesting point here is that the DWR recommended a 50

percent cut in doe permits on the Beaver from 50 to 25, but only a 30% cut on the buck tags.

5. Why on earth would you want to have a late season muzzle hunt, when you have just admitted that the buck to doe ratio is to low, and then the very next thing you do is send out 5 hunters in Early November to have an easier chance at killing 5 of our very few mature bucks.

The Beaver unit cannot sustain 2,100 hunters with so few bucks on the landscape at this time. Unlike the Article in October of last year, the Beaver unit is in the worst possible way for amount of deer. I recently (last week) went to one of my favorite areas on the Beaver and walked over 7 miles of area. This is an area that could adequately hold several hundred deer and in the past it has done just that. On this trip, I counted 18 deer. Not sure how many were buck or doe. Not sure how 18 deer spread out over 7 miles of landscape calculates on a dwr formula, but from a 50 year sportsman on the Beaver unit, it calculates to the very lowest amount of deer I have ever seen on this unit. I would assume if you were to go personally look at that unit, you would have to admit it looks like an area that needs to be shut down.

Hopefully you will make some consideration that may help on the Beaver unit. 350 tag cuts did not help a year ago. 900 tags will not help this year. Maybe if we are lucky, larger cuts and no doe permits, may start the slow process of increasing deer on the Beaver unit.

I understand the deer population concerns in Tooele City proper, but these ARE not the Antlerless deer being taken. I have hunted Settlement Canyon for over 40 years and currently run and manage public access permits to hunt on private land in Settlement Canyon. I have managed this for over 20 years as well. Long short, deer numbers are down. I have noted a number of dead and I assume to be winter kill deer on private ground this spring. I was very happy to see that the buck tags on the Oquirrh Stansbury Unit were proposed to be cut back by over 1000. It really is need.

Long short again, taking the antlerless deer out of Tooele City may be a good thing, but these are not the deer being taken in my opinion. I would highly suggest the board not approve any antleress deer tags in the Oquirrh Stansbury unit in 2020. Buck to Doe rations can only get better with more antlerless deer. This only brings in more revenue to the State of Utah in the long run.
