Comment 1: Reindeer and caribou are classified at the same species of deer (cervids). The only difference is that reindeer are domesticated and caribou are found in the wild. The proposed regulation only indicate reindeer and no reference to caribou.

Comment 2: As a current operator of the Certificate of Registration (COR) there has not been any public input when the decision has been made to change the COR nor notifications until final decision. I feel there needs to be a 45 day public comment period or some type of meeting to discuss the changes to the COR.

Comment 3: Reindeer have been domesticated for thousands of years(1). The reindeer is the only successfully domesticated deer in the world. Nomadic tribes that stretched across from Norway, Russia, and Mongolia used reindeer to ride, pack, pull sleds, milk, clothing, and food. Not much has changed to how reindeer are being used similar from today. Reindeer can be milked for human consumption as well as the antlers are sold to make jewelry, buttons, and knife handles, etc. The reindeer had an important economic role in the early establishment of our country by delivering mail and supplies to Nome Alaska in the late 19th century(2). Reindeer were also used in WWII moving equipment and ammunition in the northern countries of Europe. Under 7 CFR § 9.201, 7 CFR § 760.204, and 7 CFR § 1416.304 the federal government classifies reindeer and elk as domesticated animals. Elk on rare occasion can be handle by people verse most reindeer can be handled. So why is the State of Utah defining reindeer as prohibited and Elk domestic mammals when privately owned?

Comment 4: Chronic Wasting Disease (CWD) was first identified in 1967 but not recognized until 1978. Experimental case study of oral transmission of CWD to reindeer shows certain reindeer breeds may be susceptible to CWD, while other subpopulations may be protective against CWD in free-ranging populations(3). The only two known cases of CWD of reindeer is one wild reindeer herd was found in Norway in 2016 (4) and another in the State of Illinois in 2019. There has been rumors of more, but I could not find any documentation to proving otherwise. In the case of Elk there are several cases of CWD found in the domestic herds within the US each year. There are even three captive herds shown in Distribution of Chronic Wasting Disease in North America map, updated March 6, 2023 that the State of Utah has allows to be manage within their borders. Going back to my first question if CWD is a priority to protect the wildlife then why is Elk classified under domestic mammals when privately owned and not reindeer.

Comment 5: Sometime in October 2021 UAC R657-3 was changed to allow for reindeer to come from east of the 100th meridian allowing for new diseases to come to Utah. Why are you classifying reindeer as prohibited 2 years later?

Dear Wildlife Board Members and Director Shirley:

On behalf of Safari Club International, I would like to thank you for the opportunity to comment on the Swan Hunt Recommendations for 2023.

As you know, the Swan Hunt Recommendations for 2023 propose closing incidental harvest of trumpeter swans during the swan season and removing the mortality quota for trumpeter swans, thereby making it illegal to take a trumpeter swan. It has been analogized that because ducks require identification when hunting, it isn't implausible that swans should too be identified by hunters. SCI would submit that swan identification is inherently many, many times more difficult on the wing for an average hunter than duck identification and perhaps likely impossible should an individual bird appear in isolation. It has been stated that ten percent of all adult tundra swans do not have yellow on the lores so even that is not a definitive identification marker. Even cranes (whooping and sandhill), where the species overlap and hunting seasons occur, have many different identification markers that allow hunters to distinguish between species. As such and while balancing the Division's rationale for the proposed change, SCI raises concerns about the potential for future enforcement actions against hunters, particularly in light of conversations nationally about potentially heading towards a swan season encompassing both species as trumpeter swans continue to expand in population and range, and encourages the Division to take a light handed approach as the transition to a tundra swan only season occurs.

SCI believes that sound science-based conservation involving hunting as the primary management tool, while maximizing opportunities for all huntable species, is necessary to the long-term health of wildlife. Hunters have long paid the way for conservation, both game and non-game wildlife, and maximizing opportunity for hunting is also key to long-term funding for all conservation. Hunting benefits wildlife conservation.
