The Board noted personal observations from past years of hunting in relation to former years in which antler point restrictions were in place, as well as subsequent research project results related to antler point restrictions.

The Board commented on the potential effectiveness of shortened seasons.

The Board voiced support for the Division having made concerted efforts to propose new changes to wildlife management strategies, and for the study to begin as proposed.

The Board conversely argued that the proposed study should be considered by the Mule Deer Committee to comment on, and suggested that board members reject the proposal.

The Board asked if the Mule Deer Committee could comment on and make recommendations to the proposed study in order for the input to be incorporated in the public process in a year's time.

The Board asked what it might look like for the study if it were implemented a year after the original proposal start date, and suggested that beginning the study as soon as possible would allow biologists to gather data to then present to the Mule Deer Committee.

The Board suggested an amendment to the motion.

	 Chuck Chamberlain: Not as familiar with Bear hunts as other hunts in the State. Does the hound hunt in November mainly target male Bear over female? Any concerns about the condition of the Bears chased by hounds? Darren DuBloois: More likely to harvest males, but you may find a few females as well. Most years females are denned up at that time of year. We haven't had many real issues with their condition from chase There aren't a lot of hunters focused on Bear hunting, they are primarily focused on Cougar hunting, but may chase a Bear if they come across one. Kevin Bunnell: There are few Bears harvested during that November hunt. Verland King: Asks the same question every year. The Black Bear committee seems underrepresented by some members of the community. Sees one Agriculture representative and one for Wool Growers. Where is the representative for the Farm Bureau? Where is the representative for the Cattleman's Association? I think Sierra is good, but Sportsmen and Wildlife, the committee looks the same every year.
	 Darren DeBloois: Always struggle with who is on these committees. How many people do we have on the committee? How big does it need to be before it gets unwieldy? We try to make sure everyone's interests are represented, including Agriculture. Sierra Nelson is on the committee and she is not shy about letting everyone know what she thinks. We do have a process in place, the Board looks at those who are on the committees. Also, with Predators committees we have Sportsmen on these committees. A lot of the time, Agriculture and Sportsmen interests align. Mike Grant: How many units will the roll-out plan open up? Or sub-units or sections in the State? To clarify, the Biologists will be able to manage their specific units? Darren DeBloois: Same number of hunt units, that won't change.

	First, the Biologists go through their districts and decide what their harvest strategy is going to be light, moderate or liberal for that specific unit.
	• In the past, there was a requirement that there could only be a certain amount of light, a certain amount of moderate, etc. Last year, we changed to allow the Biologists to choose the harvest strategy based on their district, based on their experience. We overlooked the secondary requirement that we look at all of the permit recommendations, if you average all of the adult males above five and 10% of the females, they'll fall in the moderate category. Darren would need to call the Biologist and tell them that although they want 10 permits, they either need to increase or decrease permits based on statewide rule. We are asking to do away with that requirement and let the Biologists decide based on their experience.
	• Russell Gardner: What is the success rate for those who hunt with bait and hounds?
	 Darren DeBloois: High success rate for those who hunt with bait and hounds. It depends on the density of the unit. Spot and Stalk hunts are very successful on high density units.

Feels strongly that the that the Biologists should make the decisions. Frequently hears from landowners, Agriculture, Ranchers, etc. Sierra Nielson is awesome, but she is only one voice and we could have used more. There was a lot of discussion on this matter. One thing the committee felt strongly about is the need for local Biologists to make decisions, happy to see this is back. There are three Bear management strategies, even the high strategy

	 increased population. The medium and low strategies are definitely targeted toward increasing population. Unique to Bears and not other animals. Strongly encourages the RAC to support the Division's recommendations. J.J. Brewer: Utah Houndsman's Association. Thanked RAC, Wildlife personnel and the Bear Committee. 06:35:00	 RAC Discussion Russell Gardner: Question on depredation. Do we have any solid numbers on how the mule deer are affected as well as Agriculture? We talk quite a bit about the mule deer plan. Curious to see what's going to done about Elk (Inaudible) Darren DeBloois: Usually, once a deer is a year or older, they're able to escape Bears. About 15% of fawns are taken by Bears on the LaSals and San Juan units, varies from unit to unit. With Agriculture, most of the damage from Bears is to Sheep, which is why we have the Wool Growers represented on the committees. There are a few calves/cattle that are taken. A Bear can kill a lot of sheep in an evening. The number of reported incidents have dropped off in the past several years, but we keep an eye on it. We are looking into all of that. BYU has done a great job quantifying what causes a mortality and what things we ought to be concerned about. We'll keep working on that problem. Kevin Bunnell: We try to document every report of those incidents and there's an investigation done by Wildlife Services to confirm the damage was done by a Bear. We reimburse the owner. Tammy Pearson: Agreed with Verland. We need a higher representation of Agriculture on these committees. Sierra is not shy, but we need to look at having more representation on the committees. A lot of the commissioners and people she talks to are Agriculture producers. Hears a lot about depredation. We've worked hard on the Mountain

	Lions and need to do the same with Bears. Bears don't leave much evidence behind. She support the Division's recommendations.
	• Austin Atkinson: Questions mainly about what the Utah Houndsmen Association stated in the statement they sent us. Extreme winter conditions from 2023 lowered Bear populations. What mechanisms do we have in place to change permits within the three-year cycle? If there's something extreme, would you bring it before the RAC?
	• Darren DeBloois : We look at the numbers and prefer to keep it on a three-year cycle, unless there was a big emergency. Next year the Biologists will look at the last three years data and numbers and adjust accordingly. Trying to avoid annual jumping around and trying to be consistent over a period of time. 	Daniel presented the Divisions recommendations and answered questions from the RAC and public members. Reviewed the changes (increases and decreases) on each unit in the State.

	 Verland King: The units in our region are units that have livestock permits on them. Are the livestock permits increasing too? I'll bet the answer is no. Is that right, Tammy? Have there been increases?
	Daniel Sallee: I don't know, the local biologists may know?
	 Mike Wardle: I can speak on the Beaver unit. There have been increases. The Beaver Elk objective hasn't changed since 2007. We did increase tags.

	Tammy Pearson : No, there are no increases. It's a heavy lift to get the Forest Service and BLM to approve increases – even to have prior permits reinstated. Did the Elk objective change – so we are where we were before? Or just increase tags?
•	Russell Gardner: So when you increase with these proposals on units, do you contact the individual Cattlemen to get a feel of how this might impact them? Or what is the process?
•	Daniel Sallee: To recommend a change in population objective, we have to have a local committee meet, with representatives on those committees. Agriculture, Cattlemen, Wool Growers and Farm Bureau representatives are usually on these committees. Also, Sportsmen, elected officials, members of the public at large and sometimes a local Biologist. But, yes, there is a process.
•	Austin Atkinson: Sat on a couple of committees, mainly on the Southwest Desert and Beaver units when we went through the Elk Management plan. As a hunter and sportsman, if he sees 200 Elk he thinks that's not a lot of Elk. Understands Agriculture sees it from a totally different perspective. The committees he's been on it was discussed how much feed was taken away from Cattle by every Elk. The discussion is has the habitat improved? Do we have more water? Do we have more space? Are we working together so you can take advantage of your Forest Service and BLM permits and we can still have toleration for Elk. Feels consensus was that these numbers were debated and it came down to range where we could see where we were on the bad years versus the good years in toleration for Elk. Feels like representation was fair and balanced as far as participation in the meetings.
•	Daniel Sallee: The Beaver and Southwest Desert committees set specific goals to reconvene in another 3-5 years to talk about how the potential changes have played out.
•	Verland King: The Southwest Desert, Fillmore, the ones that have range in there and you quoted the drought. Is it stated in there that if there's a drought, like on the Southwest Desert, we could go from 1250 down to 1050? In the past, when we've tried to get the Division to reduce the numbers – whether it's Buffalo, Elk or whatever, we've been told you can't do it, we'll try, it will be a couple of years. By then, the habitat has been damaged. Does the plan stipulate that we can let enough permits out to get that number down? You can make those changes in the same year? Will you go below the quota that you've quoted here?

•	 Daniel Sallee: The point of having this range is to allow us to make those decreases when needed. Yes. The quotas are set early in the year, then the draw takes place around May. But, if there's a significant drought that occurs that Summer, the Statewide plan allows the August Wildlife Board to increase permits. We can put more tags in the hands of hunters to reduce those numbers the same year. We strive to maintain the population objective and stay within that range. Not sure if the numbers would go below that in the event of a severe drought.
•	Kevin Bunnell: We are below objective on several of our units now. Because of the drought, we dropped below our population objective on several units.
•	Verland King: So, one good year and we dropped below objective and we want to increase that objective because we had one good year? I think you are jumping the gun. It's common knowledge that there are a lot of Elk and it's the root of quite a lot of problems with the Mule Deer.
	Chuck Chamberlain : Was part of those discussions and that was brought up. One year doesn't make a recovery. The Fish Lake wasn't comfortable moving forward with increased numbers. That's why we came up with a range so that we can move forward and adjust within that plan. Rather than setting the numbers too low and not being able to adjust if needed. What is the metric we use to adjust up or down? Is it drought or watercycle? Range condition?
•	Jason Nicholes : In the Southwest Desert plan specifically, we stated that if permitees are being asked to cut back or come off the range early then we would reduce and manage toward the lower end of the plan.
•	Tammy Pearson : I was on the Beaver committee. There was a lot of discussion regarding the conflict with livestock, etc. There have been significant projects that have been completed – reseeds and different things. A recent fire and new habitat generated whether through water, GIP or water, WRI. We put a range in there, rather than just a top number. That leaves a place for management. Stay on the bottom end during a drought, but have the ability for expansion if needed. One year does not make a recovery on anything.
•	Riley Roberts: There were quite a few of us from the RAC who were able to be on the Committees. Assured each of the RAC members that

	 they were well represented on every level. I was on the Panguitch Lake committee, which is under population. The range we went through with the livestock, Sportsman, Fish and Game and BLM. Rather than rehashing everything, everyone was well represented. These committees were put together with well intent. Trust in those that represented you. Lots of camaraderie and cohesiveness that went on in these committees. If we need to make changes in the future, we can do that. Dan Fletcher: Can you explain how you are going to use the Elk collar data to make these decisions? In the Southwest Desert we talked about in the committee, there are areas within that unit where we will have Elk concentration as the population gets higher and we will have conflict with livestock, etc. Will you explain what we can do about those Elk concentrations as part of this plan? Daniel Sallee: With regard to depredation issues? We have quite a few tools on the Statewide plan to do that with. Ranging from private land only permits for an area to get hunters on private land. We have depredation tags and vouchers that can be issued directly to the landowner. We can hold depredation hunter pool hunts on public land around the private land. We have several tools to put pressure on problem areas. The GPS collared data was used when we split those units into two units. The data showed the Elk do cross over there. In Box Elder, we've used that data to give people depredation permits and also we use it for survival data.

- **Donnie Hunter:** Was on the SWD committee. We had great representation from Sportsmen and Livestock people. Jason provided a great presentation of what was there and what has happened the last five years. It was part of his job to make sure that those goals were met. A lot of it was habitat work, he believed there were 31,000 acres that were completed for Elk and Livestock. In the areas where there were conflicts, Jason was able to give landowners, or permitees, depredation permits to address those issues. Livestock people on our committee were pleased with what he did. We talked 3-4 hours about Elk and Livestock and what we could agree on. In the end, we had a unanimous decision to go with the number 1050 to 1250. We all left on the same page and happy.
- Scott Stubbs: I'm a Wool Grower and sat on the Panguitch Lake committee. It's been stated that we are under objective on that unit. In my mind, what makes this plan work is that we are targeting big groups. I work on the Panguitch Lake unit and even though we are under objective, for some reason all the Elk end up on my Summer country. Targeted hunts are a big issue and that's what is going to keep the livestock community behind it. It will take a long time to get to those numbers because you're going to have to kill a lot of those that are concentrating in certain areas. We all came together, supports the plan with those things in mind.
- Brayden Richmond: Sat on the Beaver Elk committee, it was a diversified group. Echos what Donnie and Scott said. The last time I sat on this committee it wasn't as pleasant. This time it was vocal, with a lot of opinions. Our committee was also unanimous. Thanked Mike Wardle. He talked to Brayden several years ago about the strategy of getting to where we are now. Mike has put a lot of effort into keeping this unit at or near objective. Right now, we are guite a ways under objective. The local community is concerned there are not enough Elk on the unit. Mike hears from both sides - not enough Elk and too many Elk. Mike has shown that it can be manage and he'll do what he says he'll do. Asking for support for the Division's plan for an increase. Excited about seeing Sportsman and Cattlemen working together so well. He is concerned about some of the comments made on the RAC tonight. Sportsmen and Cattlemen both put in millions of dollars on the ground to help the habitat for cattle and wildlife. He has never seen Sportsmen or conservation groups ever solicit to take cattle off the mountain, but he has seen Cattlemen be pretty opposed. It's critical that we get on the same page. Sportsmen are not the enemy of Cattlemen. There are a lot of enemies of Cattlemen, but it's not the Sportsmen.

	• Troy Henrie: Utah Farm Bureau, Southern Region Manager: Stated to the RAC, especially Verland and Russell, that they were included in the process. Echoes the sentiments that have already been given and appreciates the ability to be part of this process. Expects to be part of the process in the future as well. The committee process works, no one got run over. Everyone was able to get something they wanted there. There was a consensus, everyone gave something so we were able to come up with an acceptable compromise. Changes are not being proposed to increase opportunities, it's because conditions allow it. Significant fire in 2017 on the Panguitch Lake unit and that country has changed, it's completely different. Those are some of the reasons we were able to get on board with this plan. Generally, the Farm Bureau would not support the increase of Elk numbers, but because conditions allow it, we support this process and the plan.
	• Neuel Chlarson: Sat on the Beaver committee and State Committee as well. Doesn't want to repeat everything that has been said. There have been increases on the Beaver mountain and it can happen. The forest service did say, Verland, that any Permittee that was willing to put forth the effort, when there's forage that's available, that they would work with them to do that.
	• JJ Brewer: It's awesome to see Sportsmen and Agriculture be able to meet in the middle. Hat's off to that – and also to our Biologists. Thanked the Biologists, expecially Mike. Recognizes the amount of time spent. Supports the Division's recommendations, it's a good way to go.

	 Chuck Chamberlain: Read a letter from the U.S. Forest Service, signed by Michael Elson, Forest Supervisor, Fishlake National Forest and Kevin Wright, Forest Supervisor, Dixie National Forest. The Forest Service supports the proposed changed to the Elk objectives on all units in the Southern region. (This letter is attached to the minutes for review) Pleased with the way the Division handled this and the committee process.
	• Mike Grant: Grew up in the Cattleman's Association. Back then it was the Elk are coming in and we need to get them out. Great to see the comaraderie between Sportsmen and Cattlemen on these committees and it is second to none. They're willing to work together, the management and the money that goes in from the Cattleman's Association, the Wool Growers, Sportsmen to make the mountain and areas better for the animals. It's will be a success story moving forward.

- Austin Atkinson: Initially struggled with the range idea. Sportsmen are going to want the top end of the range and Cattlemen are going to want the bottom of the range. The range idea has grown on him a little bit. Believes it will help the RAC as permit numbers come up. The RAC will be able to see where we are in that range. They Biologists can speak on it, but everyone have everyone on the RAC speak on it as well. We can do that on an annual basis and not just say save all the Elk because we are below on numbers. It will allow some flexibility and a lot more public process not just a hard number.
 - **Tammy Pearson:** If Neuel's numbers went up, he's the only one I know of. He's in Millard County, so it doesn't count. The Livestock, Wildlife, Sportsmen need to stick together. We all have common enemies and we need to stick together. It's happening in other industries, on public lands and under multiple use. You look at the timber industry for example. Happy with meetings she attended on the Beaver unit, that upper and lower range is going to be helpful in the end. Will give us a management tool that we haven't had before and goals to look forward too.
 - Verland King: I've been on some of these committees too. Mainly the Bison committee on the Henry Mountains, which is maybe why I'm not invited anymore. Looks like the Ranchers got pushed pretty good, doesn't know if any of these bottom end of these units start at what the objective is now. You're top objective was certain and now you're starting that range up a hundred head or more and going 100 head to 500 head. Why are we going up higher to a range that's a lot higher? Why don't you at least start with the bottom end being the the top end of what you start at? I've never seen an increase in AUM permits on the forest or BLM that I know of. Sometimes you can talk them into extending the off date or something like that, which usually doesn't work for a person's operation. The Division is going to have more Elk. I've got to stay at the same number. As an example, I weaned, my calves were 50 pounds heavier than last year. So, I gained \$2.00, I gained a little more money. But, it I'd had another whole calf out there, maybe it didn't weigh that 50 pounds, but that a lot more money. The calves are bringing \$1500-1800 more dollars a head now. Versus the \$100 - \$200 dollars for the extra weight. Rubbed the wrong way that the Division is saying we've had a good year, there's a lot more forage out there. Thinks there's been one good year You're getting the benefit from what we've done. There deer checked their calendar, the day my depredation tag expired, they showed up. The deer population outside of my field is a lot better, they're fat and shiny and look good. This range is great, we had to argue until we were blue in the face on the Buffalo to get them to go to a lower number during the drought. Bothered that the low end is a couple hundred over what the low end was last year. Tried to increase his herd, but ended up decreasing it because of the drought. After one

	good year, he's still had to cull the herd. Down 100 head than what he could be and is allotted for. Doesn't sit well, starting a the low end a couple hundred above what the top end was last time. Elk get congregated on one place and you talk about breaking them up, good luck, let me know how that works.

07:24:05	7) Poaching Reported Reward Permits Rule Revisions (Action) - Wyatt Bubak, Law Enforcement Chief
	Wyatt presented the Division's recommendations and answered questions from the RAC and community members. Currently, the Division issues permits to individuals who report poaching incidents; however, there have been a few situations that didn't fall cleanly into this rule. These issues are addressed in this presentation.
	There are four main items in this proposal: 1. Removal of Cougar permits from rule.
	2. Provide greater protection for those who report poaching incidents, especially where their safety or livelihood could be jeopardized.
	3. The rule doesn't address what to do if someone reports two or more poaching events per year. The proposal address this issue.

SUBJECT: Inedible byproducts

In May 2023, the Utah Wildlife Board passed a revision of the Big Game Rule (R657-5), prohibiting the sale of certain inedible byproducts derived from big game animals.

Due to the impact the rule change had on existing industry, the Senate's Rule Committee repealed this portion of rule in November and asked the DWR to work with industry to come up with an acceptable alternative; one that adequately addresses the concerns of both parties and allows for continued industry operation.

Since meeting with the Senate, the DWR has been in regular communication with industry members to identify potential compromises and feel that compromise is realistic and possible. Assuming such is the case, the Senate asked that a bill be presented this legislative session. This bill would be codifying agreed upon standards.

Committee recommendations on season dates and emergency closures

- Resident/non-resident
 - No season dates for residents.
 - Season dates for non-residents (May 1-December 31).
 - Special rules for bordering states with no restrictions on Utah residents.
- Emergency closures
 - Tie emergency closures to triggers set forth in emergency feeding plan.
 - Emergency closures statewide.

Permits or licenses

- Age and license requirements
 - No license or permit required for participants 11 and under.
 - Hunting or combination license required for participants ages 12-17.
 - Hunting or combination license **and** shed antler gathering permit required for participants 18 and older.
- Certificate of registration (COR) requirement for commercial shed antler buyers.

Additional recommendations

Legislative and rule changes will be required to assign restitution values for shed antlers, make changes regarding antler crafts and dog chews, define commercial shed antler buyer, etc.

Timeline

- Present informational to Wildlife Board in January.
- Legislative session concludes in March.
- Present action item to Wildlife Board in summer of 2024.
- Changes go into effect in spring of 2025.

SUBJECT: Additional correction to prohibited fish species list

The DWR is requesting that Convict Cichlid be removed from the list of prohibited species outlined in R657-3c and R657-13-13.

The list of prohibited fish species under R657-3c and R657-13-13 was approved by the Utah Wildlife Board on November 28, 2023. At that time Convict Cichlid, a commonly sold ornamental fish species, was included on the prohibited list. In order to prevent conflict with the ornamental pet industry and any interference with interstate commerce, DWR is requesting that Convict Cichlid be removed from the prohibited list under R657-3c and R657-13-13. As with other commonly sold ornamental fishes, Convict Cichlid would be classified as non-controlled once removed from the prohibited list.
