Black Bear Management Plan Summary

•Population Goal

-Maintain healthy bear population in existing occupied habitat; expand distribution while considering human safety, economic concerns, and other wildlife species.

Population Objective

–Maintain current bear populations with reasonable proportion of older age animals and breeding females, balancing population numbers with other wildlife species through 2010.

•Performance Targets

-< 40% females in harvest

-Average age of harvested bears >5 years

-Adult Survival > 78%

-Emphasize non-lethal methods to reduce conflicts when feasible, to allow higher bear densities.

Bear Proclamation and Rule Summary of Proposed Changes

- Provide a Premium Limited Entry hunt (10% of the unit permits able to hunt both spring and fall seasons).
- Include So. Slope Yellowstone, So. Slope Vernal, Diamond Mtn., Bonanza and Central Mountains, Manti-North Units in spring harvest season extension (brings total to 9 units).
- Continue restricted summer pursuit on the Book Cliffs, San Juan and La Sal Units. Add six resident permits (3 early / 3 late) to the Book Cliffs Unit. Restricted Summer Pursuit Season Dates: Early Season <u>July 7 to July 21</u> Late Season <u>July 28 to August 11</u>

• Define "Accompany": On restricted summer pursuit units "accompany" means at a distance within which visual contact and verbal communication are maintained without the assistance of any electronic device.

• Continue Book Cliffs, #10 c, Roadless Area hunt (spot and stalk only, no hounds, no bait) and propose adding the month of October to the fall season.
