I support the majority of the recommendations. I don't think any of us estimated the lost we would have over last winter. We had the perfect storm of the worst drought year in many decades followed by a well above average winter. This combo took out alot of deer. It was amazing to see how many fawns and even adult deer were dead under Juniper trees last spring when shed hunting. It was even more evident last fall during the hunts. We did not see the buck numbers that we have been seeing in years pass in Wasatch East. It was tough to find anything with antlers. So I am definitely on board with the general season decrease in tag numbers. I am disappointed in the fact that the Wasatch East unit saw no change in tag numbers. The DWR even mentions that Northeast Utah was one of the hardest hit with snow last winter. I couldn't believe how much snow was in the winter range areas that are usually loaded with wildlife. The die off was significant. Every other Juniper tree in rabbit gulch had dead deer under them. And then to go on the hunts from August through November and see very little deer was discouraging. I disagree that the Wasatch East unit buck tags should stay the same. There is no way they are still sitting at the same buck to doe ratio as they have been the last few years. I think 19 bucks per 100 does is inaccurate. I spend a lot of time on this unit and would like to see a decrease in tags on this unit as well as all the others listed. The whole state took a big hit the with two hard winters and a drought summer in between. I think all units should see a decrease in tag numbers. We need to let the deer recover.

The DWR always talks about protecting animals in their winter range and not harassing them during the toughest time of the year, yet we allow these cow hunters to chase them and hunt them in the snow until the end of January? Why is this? I wish we could get a good answer. These poor does and cows are chased from August to February and don't stand a chance. If we want to get the deer and elk herds up to objective then we should look at cutting these tags and not stressing the females that are carrying our new recruitment during the hardest part of the year. Just my thoughts.

There needs to be a more detailed plan on the individual units themselves. On a northern unit that experiences a heavy winter one year action should be taken to lower tags on those units that experience sudden changes. More specific management plans and more regular evaluations need to take place. On heavy winters tags need to be cut. If huge fires wipe out winter range or habitat and it effects population there needs to be a way to adjust tag numbers to compensate for such things. I would like to see a 3 point or better for people over 18 in some areas to help quality as well. The moose on the wasatch unit needs to be looked at and addressed as well if the population is struggling there needs to be a drastic cut in tags or maybe even suspend the hunt until numbers and quality come back. We need to try and get the elk herd back to how it was in the late 2000s and early 2010s with quantity and quality. The health and well being of wildlife should come first

To: Members of the Regional Advisory Counsel's

Utah Wild Sheep Foundation has reviewed, on a unit by unit basis, the DWR recommendations for Bighorn Sheep ("BHS") permits for the 2020 season. As an organization, we are excited about the overall increase in permit numbers and believe it reflects the hard work and commitment made to BHS recovery by the DWR and related sportsmen/conservation groups. We also understand and support the need to reduce permit numbers on certain units, as necessary, in order to maintain age objectives, overall population health and quality hunting experiences for these much sought after hunting permits.

We would like to express our concern in regards to several units in the state that we consider "recovering" populations. These populations of both Desert and California Bighorn have all suffered catastrophic disease events, which resulted in substantial declines in overall population and resultant permit numbers. The limited hunting opportunities that remain have been very difficult, at best, with substantial financial and time commitments required, in very difficult terrain, to have a reasonable opportunity for harvest. As these populations recover, we feel it is appropriate to have a more conservative approach in respect to increased permit numbers, in order to ensure continued population recovery and quality hunting opportunities.

- San Juan subunits-last year there were 3 permits issued with 1 successfully filled. There are 5 permits being recommended for 2020.
- Dirty Devil-last year there were 2 permits issued and there are 6 permits being recommended for 2020. Although both hunters were successful in 2019, they hunted with extremely knowledgeable guides and spent considerable time afield. There has also been a consistent decrease in the age class of rams harvested on this unit, over the past 4 years.
- Stansbury Mtns-last year there were 3 permits issued and there are 5 permits being recommended for 2020. This unit is well under population objective and has been supplemented by transplant for the last 3 years.

Additionally, as one of the organizations that participated in updating the Statewide BHS management plan in 2018, we believe the permit recommendations were set as more of a guideline rather than hard numbers and want to reiterate our support for giving the DWR flexibility in determining appropriate permit numbers.

In conclusion, we would like to thank the DWR and its personnel for their continued commitment to BHS management and recovery throughout the State of Utah.

In reviewing data from deer studies going on currently, we are not seeing a high loss of fawns or adult does. This is recent data obtained from the study being conducted by BYU. The study does not support the killing of more cougars, but the director is caving to special interests and increasing tags on many units. The passage of the Albrecht bill allows for the director to increase permits WHEN cougars or bears ARE proven to be a detriment to herds, but the current date from BYU is not supporting the increases on the amount of units we are seeing increases imposed. The Bookcliffs spike elk hunt needs to end. As a hunter of the Bookcliffs and an outfitter who lives in Green River Utah I have years of experience and observations there., I spend all year and especially each fall on the unit and have done so for the past 30 years, I strongly disagree with the spike hunt. The reduction of mature bulls is alarming. The elk herd is not at objective and allowing some more mature bulls to be on the units does not compromise the forage available. We are harvesting more spike elk than can be sustained to keep a healthy mature bull herd. The reduction each year of mature bull hunting to allow for spike elk hunting is not an opportunity improvement for a hunter who chooses to hunt a mature bull on a unit such as the roadless Bookcliffs who many dream of the backcountry hunt. Spike elk hunts should be on units at herd objective and not on units that are under overall population objectives. The Bookcliffs is the area Utah is struggling to manage a healthy elk herd and continuing the spike hunt is compromising the unit. The argument that the spike hunt is an opportunity for families to get together to hunt is not what I see on the spike elk hunt. It is much more made up of adults males and not wives and kids, especially the roadless portion.
