While I support this proposal, I do have a couple concerns.

First of all, thank you for what you all do, and thank you for providing us with the best possible public process during this pandemic.

This is a great opportunity for hunters to be able to pursue an animal that many may never draw in their lifetime.

That said, I don't think this is a proper tool to try and reduce point creep.

To make this effective, you need as many hunters on the ground as possible, and such a deterrent--especially the lifetime waiting period--will most certainly stop the vast majority of would-be bison hunters from attempting this hunt.

It's already a VERY difficult hunt, and most likely limited only to hunters with access to pack animals, and hunters who are in extremely good shape.

A couple other key points to consider.

- 1) Our bonus point system is used in Limited Entry hunts... This is not a limited entry hunt, there is no limit on who, or how many can purchase the tag.
- 2) The lifetime waiting period is only for once in a lifetime hunts... This is very likely a hunt that will continue for several seasons, and as such, this is not a once in a lifetime hunt, and that waiting period should not apply.

All that said, if the waiting period and bonus points were only forfeited if the hunter is successful, then perhaps I could consider that a fair compromise.

Even if I didn't take this opportunity to do my scouting prior to the hunt.

I understand your concerns, as listed in the presentation and desire a zero population of bison in this unit, it makes more sense to me to incorporate a bison plan rather than try to kill them all off, which won't happen anyway. The hurd will continue to migrate into this area forever.

By allowing unlimited permits when the BLM and other agencies are limiting access will create a terrible mess for the BLM and others, as the permit holders will be pressuring them in a very big way to gain access, they will ultimately be forced to increase access permits which will end up undermining the reasons they have for limiting access in the first place.

AND lastly, to take my points away after all these years of me trying to get a tag for a place I know I can access easily for scouting and hunting is a terrible idea. This proposal, should it be accepted will only end up being a "rich mans" hunt with guide services providing access via helicopter drop hunts. And this will further infuriate the BLM and other agencies.

Antlerless elk are more understandable due to damage caused to fences, range ground, etc.. That being said, I would like to see the division take a stricter approach when it comes to hunting antlerless deer in the winter-impacted units, namely, Chalk Creek, Morgan, South Rich, Cache, East Canyon, and Ogden. I have watched the herds for decades and have realized they are simply too volatile. One bad winter or drought can put us in a bad situation. Again, I understand that problem animals that congregate in yards and around roads cause issues, but at the same time, people chose to live amongst them and the herds shouldn't have to suffer because of that.

With elk, I would propose that the cow season only runs to January 15th instead of January 31. My concern is not for the elk, but for the deer that are inadvertently pressured by cow elk hunters. Those last couple weeks are crucial for deer as everyone knows. A reduction in the timeframe would help alleviate pressures already apparent from any given winter.

His plead was we need to do something today that is meaningful and significant. If we go year after year making small changes to the number of tags we wont have a significant impact for a number of years. With this argument in mind I ask is a 10% decrease in tags enough? Or do we need to take a larger cut this year and possible the next so that we can get our deer herd to a place where we can have both more opportunities and higher quality hunts. We need to think about the long term goal of our deer herds not just making people happy today by giving them a tag. The people are already mad about the number of deer in our herd that is why their is a proposed change to how we manage predators. Why are we issuing doe tags if we are not at our population objective? Are we really wondering why our heard is not growing when we taking out the members of the herd that actually rear the young.

As a side note, I am baffled by why Kamas is a limited entry cougar area? I can understand why you might make areas with a lot of private land (that isn't farmland) limited entry, like chalk creek and the oquirrhs, since accessing the prey animals is sometimes limited and the increased cougar numbers might control the population, but in an area like Kamas where it seems there are so few deer - or at least very low success rates, it would be nice not to have a ton of cougars taking deer as well - unless this unit really is up to carrying capacity. Last November I hiked up one of the mountains in Kamas and saw what I am pretty confident where about 5 different sets of cougar tracks in one line up the mountain. That seems like a lot. That said, thank you for decreasing the deer permits on this unit for this year, but it seems like removing some cougars might help even more. It just seems like anything that can be done to help this unit would be good.

And would there really be a huge crash if you attempted to bump up to a carrying capacity a little at a time and carefully watched the body and land conditions?

For example, why the increase on Kamas where the pop obj is 850 and current population is 700?

Utah Wild Sheep Foundation has reviewed, on a unit by unit basis, the DWR recommendations for Bighorn Sheep ("BHS") permits for the 2020 season. As an organization, we are excited about the overall increase in permit numbers and believe it reflects the hard work and commitment made to BHS recovery by the DWR and related sportsmen/conservation groups. We also understand and support the need to reduce permit numbers on certain units, as necessary, in order to maintain age objectives, overall population health and quality hunting experiences for these much sought after hunting permits.

We would like to express our concern In regards to several units in the state that we consider "recovering" populations. These populations of both Desert and California Bighorn have all suffered catastrophic disease events, which resulted in substantial declines in overall population and resultant permit numbers. The limited hunting opportunities that remain have been very difficult, at best, with substantial financial and time commitments required, in very difficult terrain, to have a reasonable opportunity for harvest. As these populations recover, we feel it is appropriate to have a more conservative approach in respect to increased permit numbers, in order to ensure continued population recovery and quality hunting opportunities.

- San Juan subunits-last year there were 3 permits issued with 1 successfully filled. There are 5 permits being recommended for 2020.
- Dirty Devil-last year there were 2 permits issued and there are 6 permits being recommended for 2020. Although both hunters were successful in 2019, they hunted with extremely knowledgeable guides and spent considerable time afield. There has also been a consistent decrease in the age class of rams harvested on this unit, over the past 4 years.
- Stansbury Mtns-last year there were 3 permits issued and there are 5 permits being recommended for 2020. This unit is well under population objective and has been supplemented by transplant for the last 3 years.

Additionally, as one of the organizations that participated in updating the Statewide BHS management plan in 2018, we believe the permit recommendations were set as more of a guideline rather than hard numbers and want to reiterate our support for giving the DWR flexibility in determining appropriate permit numbers.

In conclusion, we would like to thank the DWR and its personnel for their continued commitment to BHS management and recovery throughout the State of Utah.

The slow elk (cows), have taken over. We think it is by design. Money from grazing talks. You can't put your boot down in most all of the drainage's on the North side, without stepping in a cow pie. It doesn't take a rocket scientist to see what is going on. It doesn't take a F&G Biologist to tell us. Personally I won't put in again in this area for elk until I see the population shift. Most all of us that frequent this area can see cause and effect.
