The deer population on the Beaver unit maybe beyond repair. Some concerns that I see are as follows:

The last 2 years your data has shown the buck to Doe ratio dropping, from 18 to 15, yet the small tag cuts the last two years have not helped. At this point to get the buck numbers back up to 18 will require cutting many more tags than 900. I would suggest at least half to start with. If you do not cut enough right now to make a difference, the only option you will have left is to close the unit, because as of right now there are no deer numbers on this unit.

Why are we adding to the problem by giving 5 late season muzzle tags. We just admit the buck numbers are low and then we add 5 more tags for easy kill of more bucks. This should only be handed out to units that are thriving, not the units that are declining.

You recommend cutting doe tags from 50 to 25 next year on the Beaver. The deer numbers are in sad shape. There should not be any Doe deer taken until numbers can make necessary increase. The Pine valley unit show plenty of deer and a buck to doe ratio doing very well. Even in that unit you are cutting doe numbers from 420 to 140. It you have a unit like the Beaver that is in great need of increasing deer, why would you give out any tags at all.

We have spent 40 years doing habitat restorations and the herds keep declining. This is an EXCUSE!

Many areas that Sheep live are almost impossible for the houndsman to effectivly harvest cats. There is not enough snow to cut tracks and the terrian makes it almost impossible to chase. I would like to see when an area falls below objective (which is everywhere in the State right now) we open up trapping of cougars. This creates opportunity for not only houndsman to particiapte affectivity and still can be done within a quota system. Also an objective of Toms and Females could be set. You can let a cat out of trap to live another day if the Tom quota is full. The DWR is always talking about OPPORTUNITY, this has never been the case for predators.

Also we need to bring back some type of poison, it is by far the most effect way to kill coyotes. I know this is a controversial topic. To: Members of the Regional Advisory Counsel's

Utah Wild Sheep Foundation has reviewed, on a unit by unit basis, the DWR recommendations for Bighorn Sheep ("BHS") permits for the 2020 season. As an organization, we are excited about the overall increase in permit numbers and believe it reflects the hard work and commitment made to BHS recovery by the DWR and related sportsmen/conservation groups. We also understand and support the need to reduce permit numbers on certain units, as necessary, in order to maintain age objectives, overall population health and quality hunting experiences for these much sought after hunting permits.

We would like to express our concern in regards to several units in the state that we consider "recovering" populations. These populations of both Desert and California Bighorn have all suffered catastrophic disease events, which resulted in substantial declines in overall population and resultant permit numbers. The limited hunting opportunities that remain have been very difficult, at best, with substantial financial and time commitments required, in very difficult terrain, to have a reasonable opportunity for harvest. As these populations recover, we feel it is appropriate to have a more conservative approach in respect to increased permit numbers, in order to ensure continued population recovery and quality hunting opportunities.

- San Juan subunits-last year there were 3 permits issued with 1 successfully filled. There are 5 permits being recommended for 2020.
- Dirty Devil-last year there were 2 permits issued and there are 6 permits being recommended for 2020. Although both hunters were successful in 2019, they hunted with extremely knowledgeable guides and spent considerable time afield. There has also been a consistent decrease in the age class of rams harvested on this unit, over the past 4 years.
- Stansbury Mtns-last year there were 3 permits issued and there are 5 permits being recommended for 2020. This unit is well under population objective and has been supplemented by transplant for the last 3 years.

Additionally, as one of the organizations that participated in updating the Statewide BHS management plan in 2018, we believe the permit recommendations were set as more of a guideline rather than hard numbers and want to reiterate our support for giving the DWR flexibility in determining appropriate permit numbers.

In conclusion, we would like to thank the DWR and its personnel for their continued commitment to BHS management and recovery throughout the State of Utah.

I have hunted this unit since I was old enough to hunt and I am now 39 years old i have a lifetime License enabling to hunt deer every year and I have not missed a year since I was old enough to hunt and I have hunted the south west desert every year and have never had a tag for another Utah general unit, I am a licenced hunting guide in Utah as well as Nevada and spend the majority of my time every year hunting the south west desert.

Last year as I prepared for guiding a limited entry elk hunter as well as my dedicated hunter deer hunt I spent several days scouting as well as ran 65 trail cams from June 1st- November 15th and to say it lightly our Deer herd on this unit is tearable. I seen at most 30 bucks in all my scouting as well as trail cams and no more the 5 mature bucks and no more than 200 doe from June-Nov 1st then a few more deer and bucks started showing up on their winter grounds for the rutting season, If I'm not mistaking it is later in November when the DWR does there population count and this is when most of the deer has migrated from other units and across the Nevada border to their winter grounds.

This is the first year that I have ever considered hunting a different unit in Utah because the deer Hurd on south west Deseret is tearable there is to many predators and the division has given to many tags on this unit, I know the division has only given 700-800 tags on this unit the past few years but from june-November there is not 700 total deer on this unit. I would be willing to donate my time and help assist in any way regarding the South West Desert. Thanks!

Thanks for your time and working through this tough time. In addition to the predator management i feel like certain areas we have been doing a good job but others we are falling behind.

For instance the Fishlake/Thousand lake plateau, in the past few years we have seen a huge jump in bear population in certain parts of the unit where other parts of the unit is staying the same. The areas that have a larger population we are starting to see less fawns and less cows and calves in the spring. These areas i don't see a lot of bear hunters and are not hit as hard as other parts of the unit by bear hunters.

I would like to see the unit split up into a fishlake east and fishlake west and possibly even making thousand lake its own unit for bear management. we have done this for deer having fishlake and then Thousand lake as 2 different units, cow elk we have fishlake east and west and for cougar we have the fishlake unit and the 1000 lake unit but no division for bear. If we were to do the same for bear as we have done for others we could separate hunters to in a sense force them to other parts of the unit to help keep bear populations in check across the whole unit. fishlake has a pretty good defining line to where you could separate it the same as the cow elk using the scenic bi way from highway 72 up through mill meadow to Johnson reservoir north through 7 mile gooseberry and down to i 70. Thousand Lake, living in loa and spending alot of our time on the thousand lake and running trail cameras on both the fishlake and thousand lake on both units i have never seen such a poor deer herd as far as numbers go. Im not talking about numbers around the fields of these units because there is alot of deer in the fields but as far as deer on the mountain during the hunts we dont have the number of deer to support your proposed numbers of 250 permits. during the time of the division counts the deer are congregated in your zones that you count but we are counting fishlake, thousand lake and in some areas boulder deer on your thousand lake quadrants.

elk,

i have guided elk on the fishlake unit since 2005 and hunted it since i was a young kid. Last year the numbers of elk on the unit was down overall and according to the numbers we have fallen to 4750, population objective for the unit is 5000 to 5900 and the age class for bulls 5.5-6. We are down on numbers and staying at the age class objective so why are we adding more tags to the unit for elk.

every unit in the greater plateau is at an age class of atleast 6.5-7 why is the fishlake being held at 5.5-6? if we were to raise the age class of the fishlake unit what would this do to the number of permits? The quality of bulls on the fishlake over the past 3 years other than a couple bulls each year has fallen off dramatically. I know to satisfy quantity we have left units at certain age class but if we are going to manage the greater plateau as one herd then maybe we should get the age classes to match a little closer. Again over all numbers on the boulder dutton, monroe and fishlake are below objective and we are decreasing tags on 3 of these units for cows but adding tags on the fishlake for both bulls and cows that our elk committee views as one herd.

I would like to address the permit numbers for desert bighorn sheep on the Kaiparowits units. As someone who has over 20 years experience with sheep on these units from my time as a being a M.S. graduate student studying them, a Utah division of wildlife biologist over these units, and now currently a sportsman and sheep hunting outfitter, I am concerned about the rapid increase in permits the last couple of years particularly on the west subunit. I am well aware of the balance to harvest rams when you have them, before issues such as disease have a potential impact on them. However, if you look at the Zion unit which for years has been the best trophy unit in the state, this is no longer the case. Using the Zion desert sheep unit as an example where consistently high permit numbers along with aggressive removal of sheep for transplants, this unit is now a shadow of what it once was in terms of numbers and quality of rams. Tag numbers are being cut again on Zion for 2020, to a point nearly half of where they were at their peak. While the Zion has challenges with nearby communities creating exposure to domestic sheep or goats, the Kaiparowits does not. The Kaiparowits West subunit has been a great unit for hunters looking for big rams for many years. But with the current trend in increasing permit numbers, this will not last. In addition to draw permits, the Kaiparowits units have 2 conservation permits each year, at least one of those possibly both will harvest on the west. Additionally, there is one K-west specific tag given to the SLC Hunt Expo convention. And in 2019, the statewide conservation and statewide sportsman permit holder's for desert sheep BOTH killed on the K-west. So there were four extra rams killed on the K-west in 2019 above and beyond the draw tags. With the current declined status of the Zion unit, the K-west will continue to bear the brunt from extra harvest. Please keep all of this in mind when considering recommending adding any new public draw permits for 2020. With elk we have a handful of units and with deer we designate a couple units as premium units with higher age objectives and we manage for overall the best quality. My question is why can we not do that for desert or Rocky Mountain sheep as well? The units across extreme southern Utah such as the Zion and Kaiparowits most notably, which have Nevada and Arizona transplanted sheep and genetics, have proven they can produce great rams if given the opportunity. I ask the Wildlife Board and RAC's to not increase the K-West tags for 2020. The unit can not keep producing enough older, trophy rams with the continued permit increases.

The K-west and east subunits have not been helicopter surveyed since 2018, and the Escalante has not been surveyed since 2017, yet permit increases have been recommended in these units again for 2020. The bighorn sheep management plan has a guideline to recommend permit numbers based on 30 to 60% of the total rams counted that are six years and older. I am requesting that on units like the West that have the ability to produce bigger rams with better trophy potential, that the 30% guideline and nothing higher is used for setting permits. Based on the last survey on the K-west subunit In 2018, there were 40 rams counted ages 6 and older. Using a 30% guideline for a permit recommendation, that would put the number of harvested rams on the West at 12 for 2019. In 2019 there were 14 rams killed on the unit with again an increase proposed in 2020, plus the

extra tags as mentioned. I don't believe that the majority of those that have waited to draw permits for these once in a lifetime species, are interested in shooting just any ram. There are other units across Utah that are not capable of producing as big a rams at the Zion and Kaiparowits units. We should use those units as the types of units that increased opportunity can occur. I urge the Wildlife Board and RAC's to manage the units like Zion, and Kaiparowits West and East units that have best demonstrated the ability to produce the best rams in Utah, to be managed a bit more conservatively from a tag number standpoint, using the low end 30% guideline as previously mentioned.
