The system has the projectile exclusively loaded through the muzzle with a ramrod, there is no other way to load a projectile for this firearm other than through the muzzle.

I would like to again respectfully request that the Utah DWR RAC considers declining this proposal for a definition change.

I am more than happy to offer any technical assistance and provide any needed data on the system for further review.
