Since 2000, DWR has been consistently ratcheting up the number of black bear hunting permits. In 2000, the combined hunter harvest and depredation take was ~100 animals, and last year it was nearly 600. I understand that the Division believes that the black bear population has consistently grown in the last 20-30 years, but on the other hand basic ecology tells us that a population should not exceed the natural carrying capacity of its habitat. Speaking of which, I am concerned about the current carrying capacity of our black bear habitat, with the very real effects of climate change we are now already seeing. This includes many more wildfires in the coming years that will occur in bear habitat. Now would sure seem like a good time for DWR to "press pause" on the steady increase of bear tags, and abide by the Precautionary Principle. As they do so, the Division should utilize its very capable wildlife biologists, who should team up with spatial analysts from USU or BYU and develop a predictive spatial model that looks 5, 15, and 25 years out and integrates the functional level of bear habitat combined with predicted climate change impacts on habitat. Until that happens I fear that, if the Division does not reduce bear harvest next year, it is playing fast and loose with our bear population.

I think totally doing away with camera's that transmit pictures is complete overreach and does nothing to help big game. I am even more concerned about banning the use for bears on a baited hunt. I have used cell cameras for the past 5 years to monitor some of my favorite spots that are remote. In the 5 years since I bought one I have not harvested a single animal anywhere near my cameras but have enjoyed being able to watch wildlife without having to tromp through their bedding areas and disturb them. Because its been of little benefit I am less concerned about it for elk and deer, but very strongly opposed to it during a bear bait season. Drawing a bear permit has almost become a once or twice in a lifetime permit. Cameras allow the monitor of the bait and what bears are hitting the bait in a much more thorough manner. It is often that a sow comes to the bait before her cubs and identifying boar and sow can be difficult in the heat of the moment. Being able to receive regular pictures is priceless in learning what bears are coming to a bait and identifying sows and boars. If the goal of the hunt is to only take mature boars why in the world would be limit any tool that would allow a hunter to better study the animals coming in. I would argue that having transmitting cell cameras will not in any way make a hunter more or less likely to harvest a bear, but rather much more likely to harvest the correct bear. When I assisted a newer hunter who drew a bait permit a few years ago I found that one of the baits was being hit exclusively by a large, older female and the cubs would not appear for 5-10 minutes. Knowing this I was able to warn the hunter and discourage him from even sitting on that bait at the time because I was certain it would be too easy for him to accidently kill a mother bear. I understand the need to not have guides with hundreds of cameras tracking every movement of game, but the average guy with 3 or 4 cameras is not a problem and we should be trying to address the real problem and not continue to make things hard for the average guy. I would fully support a limit on the number of cameras in a given area by any individual or persons with access to those images. We have enjoyed the pictures we receive as much as the hunt itself. Either I am the worlds worst hunter, or these cameras do nothing to increase my success rate. Have there been any studies done on the topic or is this a knee jerk reaction by people who have never used trail cameras and are too lazy to scout thinking its a magic bullet. I know dozens of people who have cameras. Not one has every reported being able to harvest an animal because a remote picture suddenly came through and the animal was waiting by his camera when he arrived. If there are problems with guys putting up a hundred cameras in one draw then lets ban that. Not the guy with 2 cameras miles and miles apart that enjoys watching the animals year round.
