Especially with guided fishing in Utah. I personally feel that Kokanee have been getting over fished throughout the state especially by guided anglers. I would like to see the Kokanee season closed August 15 rather than in September. The pictures posted by fishing guides on social media show the majority of the fish they catch after July are fish that are changing to their spawning appearances. I have eaten Kokanee that have just started changing to a pinkish color and they are not worth eating when they are starting to change color in my opinion. I understand that the guides are trying to make a living guiding anglers for Kokanee but they are keeping daily limits for multiple anglers everyday throughout the season and even though the limit is only 4 per person the multiple people and multiple days they are fishing it adds up to I can only imagine to several hundred fish being caught for each guide every season. I feel a 2 fish limit statewide for guided anglers on Kokanee would help with natural recruitment and overall size of mature fish. Thank you Justin
