They aren't being managed for the same quality/quantity of elk. In my mind, the plans should be separate to reflect differences so the division can make better informed decisions regarding both limited and general units. From my observations over the past 5-10 years, the fencing along I-15 has been effective in reducing the amount of elk crossing from the LE units to the general units and vice versa. Might be worth considering on other large units that have sub sections that are managed differently.
